



## INFORMATION ON THE PROCESSING OF PERSONAL DATA EX ARTT 13/14 REG UE 2016/679 MIGLIORA SRL

## DATA SUBJECTS: WEBSITE NAVIGATORS.

**Migliora S.r.l.** as the owner of the processing of your personal data - in accordance with EU Reg. 2016/679 (commonly called "GDPR") - hereby informs you that the legislation in question provides for the protection of data subjects with respect to the processing of personal data and that such treatment will be based on the fundamental principles of fairness, lawfulness, transparency and protection of your privacy and your rights. Your personal data will therefore be processed in accordance with the legal provisions of the aforementioned legislation and the confidentiality obligations provided therein.

PURPOSE AND LEGAL BASIS: Your personal data will be processed in accordance with the legislative provisions of the above-mentioned regulations and the confidentiality obligations provided for therein; in particular, your data will be processed for the following purposes related to the implementation of legislative or contractual obligations: a) purposes inherent to the performance of a contract to which you are a party or to the implementation of pre-contractual measures taken at your request (e.g.: request for contact via the "Contact" form etc.); b) purposes necessary to ascertain the existence of a contractual relationship between you and the company. ); b) purposes necessary to ascertain, exercise or defend a right in court or whenever the judicial authorities exercise their jurisdictional functions; c) purposes of statistical research/analysis on aggregate or anonymous data, without therefore the possibility of identifying the user, aimed at measuring the functioning of the Site, measuring traffic and assessing usability and interest;

**METHODS OF PROCESSING**: your personal data may be processed in the following ways: with electronic computers using software systems managed or programmed directly or by third parties; entrusted to third parties for processing operations; temporary processing in anonymous form.

All processing is carried out in compliance with the methods provided for in Articles 6 and 32 of EU Reg. 2016/679 and through the adoption of appropriate security measures.

**PERSONS IN CHARGE OF PROCESSING**: your data will be processed only by personnel expressly authorised by the Data Controller and, in particular, by the following categories of employees: administrative; commercial; programmers and analysts.

**COMMUNICATION OF DATA**: Your data may be communicated to external parties for the proper management of the relationship and, in particular, to the following categories of recipients including all duly appointed data processors: subjects necessary for the provision of services such as, for example, the sending of e-mails and communications and the analysis of the functioning of the Website, which typically act as data processors of Migliora S.r.l. (see Cookie Policy).

**DATA DISCLOSURE**: Your personal data will not be disclosed.

**PERIOD OF DATA STORAGE**: in accordance with the principles of lawfulness, purpose limitation and data minimization, ex Art. 5 EU Reg. 2016/679, the storage period of your personal data is established for a period of time not exceeding the performance of the services provided.

**RIGHTS OF THE DATA SUBJECT**: The data subject has the right to obtain from the data controller the erasure (right to be forgotten), restriction, updating, rectification, portability, objection to the processing of personal data and to exercise all the rights pursuant to Articles 15, 16, 17, 18, 19, 20, 21, 22 EU Reg. 2016/679.

The data subject has the right to obtain confirmation of the existence or not of personal data concerning him/her, even if not yet recorded, their communication in intelligible form and the possibility to lodge a complaint with the Supervisory Authority.

Specifically, the data subject has the right to obtain information on: the origin of the personal data; the purposes and methods of processing; the logic applied in the event of processing carried out with the aid of electronic instruments; the identification details of the data controller, data processors and the designated representative ex Art. 5.2. EU Reg. 2016/679; of the entities or categories of entity to whom or which the personal data may be communicated or who or which may get to know said data in their capacity as designated representative(s) in the State's territory, data processor(s) or person(s) in charge of the processing.

Furthermore, the data subject has the right to obtain the updating, rectification or, when interested, the integration of data; the cancellation, transformation into anonymous form or blocking of data processed unlawfully, including data whose retention is unnecessary for the purposes for which the data were collected or subsequently processed certification to the effect that the operations as per the preceding points have been notified, as also related to their contents, to the entities to whom or which the data were communicated or disseminated, unless this requirement proves impossible or involves a manifestly disproportionate effort compared with the right that is to be protected; portability of the data.

Finally, the data subject has the right to object, in whole or in part: on legitimate grounds, to the processing of personal data concerning him/her, even if pertinent to the purpose of collection; to the processing of personal data concerning him/her for the purpose of sending advertising materials or direct selling or for carrying out market research or commercial communication.
